WOSB Sole Sourcing Requirements

Before considering small business set-asides, Contracting Officers must generally consider a WOSB or Economically Disadvantaged WOSB. In the final rule under <u>FAR 19.1506</u>, established by the U.S. Small Business Administration (SBA), WOSB program sole source awards can be made based on these requirements:

- The NAICS code for the contract is considered substantially underrepresented as defined by the SBA (Wheelhouse Group NAICS falls under this guidance)
- The contract value is up to \$4 million for goods and services or under \$6.5 million for manufacturing (including options)
- The WOSB is determined to be a responsible contractor with respect to performance
- After conducting market research, the Contracting Officer does not have a reasonable expectation that two or more WOSBs will submit offers
- The expectation that only one WOSB will perform the work, as determined by the Contracting Officer
- Award can be made to the WOSB at a fair and reasonable price


